# Morval Parish Council Forward Planning

The purpose of this document is to enable the public to be aware of priorities identified by the parish council and of the steps it is taking to achieve the goals listed.

The first two tables give details of priorities which the council identified for the Community Network Area and matters that have been brought to the council's attention on at least one but usually on more occasions whilst the final table gives details of priorities that have been brought to a conclusion since 2014.

## The following were identified as priorities for the Parish following a request from the Community Network Support Officer.
