# 07.21/03. Public Participation

- I. Issue raised regarding poor signage and misinformation regarding footpaths. This was later discussed (agenda item 07.21/11)
- II. NDP Update Steering Group Chairman reported that Cornwall Council are now happy with all documentation submitted and will be moving on to the next step.
- III. A representative for planning application PA21/05033 presented more detail regarding the proposal.
- IV. The Chairman referred to reports about the Village Green and stressed that the Parish Council had no intention of stopping young people playing there, especially while there were no other play areas available to them.

# 07.21/04. Minutes of the Monthly Meeting of Morval Parish Council held on 16th June 2021

It was proposed, seconded and **RESOLVED** that the minutes of the meeting held on 16<sup>th</sup> June 2021 were an accurate record of the meeting.

# 07.21/05. Cornwall Councillor Report

Cllr Toms gave an overview of his activities that may affect the parish since the last meeting:

- I. The boarding at Farriers Way is proposed to be replaced with fencing but this will require planning permission.
- II. The action to move the 30mph speed limit down to the junction A387 with B3253 will be completed within the next few weeks.
- III. The action to design and install the junction at Farriers Way is currently being worked on.
- IV. A meeting has been agreed to discuss the play park with Velven Harding.

- V. All roads in the parish have been checked for potholes and will be every 3-6months. Any new ones identified should be brought to ClIr Toms' attention.
- VI. Regarding the closure of Sandplace Road, it is hoped that traffic lights will be used in the next week or so to open the road while works continue.

**ACTION**: Cllr Kitson and Cllr Pengelly to check previous planning applications to understand who is responsible for future maintenance of the land allocated for amenity space adjacent to Farriers Way. **ACTION**: Cllr Kitson, Cllr Hutchins and Cllr Pearn to attend the meeting on 27<sup>th</sup> July at 10am.

It was proposed, seconded and RESOLVED to SUPPORT PA21/05033 – (Cllr Hutchins left the meeting at 19:35 and rejoined at 19:40) Siting of two glamping pods – New Barn Stud, Cutparrett, Widegates. It was proposed, seconded and RESOLVED to SUPPORT PA21/05177 - Construction of two extensions onto an existing agricultural building for agricultural use – North Park Tregastick Lane, Widegates. It was proposed, seconded and RESOLVED to SUPPORT However, there remained concerns around the state of the unadopted Tregastick Lane and the access to the junction of the B3252.
